## OVERVIEW

Practitioners work with children, young people and families, including carers, to achieve positive and sustainable change in their lives. They work alongside other professionals and organisations to share the responsibility for improving outcomes.

## ROLE PROFILE

### *Option 1: Practitioner in Children's Residential Care*

These Practitioners work in a variety of settings, such as a children's home, a residential special school or a secure children's home. They will take the lead in developing and delivering the child's placement plan.

### *Option 2: Children, Young People and Families Practitioner within the Community*

These practitioners will work in settings as diverse as family homes, youth centres, early years, youth justice, children's centres, educational settings and the community. They will understand the importance of and be skilled in, early intervention and safeguarding work.

## YOUR APPRENTICES' LEARNING JOURNEY

Your apprentices will complete a 24 month apprenticeship learning journey. Their journey will include achievement of either Level 3 Diploma for Residential Childcare or Certificate in Higher Education in working with Children Young People and Families. A minimum of Level 2 English and Maths is required prior to taking the End-Point Assessment.

On completion of their learning journey, apprentices will undertake an End-Point Assessment, with an independent iCQ assessor.

Throughout their journey, your apprentices will record and update their progress using iCQ's **iLearner** system, and their End-Point Assessment will be delivered using **iLearner**.

# APPRENTICESHIP STANDARDS END-POINT ASSESSMENT

## CHILDREN, YOUNG PEOPLE & FAMILIES PRACTITIONER - LEVEL 4

### ► **OBSERVATION OF PRACTICE**

An 80 to 90-minute individual observation of the apprentice at work, consisting of a live setting practical example. This includes a 15 to 20-minute question and answer session.

### ► **COMPETENCE INTERVIEW**

A 55 to 60-minute structured discussion between your apprentices and an iCQ assessor. Questions and discussion topics will focus on the work the apprentice has undertaken, the strengths demonstrated and will consider any gaps or weaknesses in knowledge, skills or behaviours.
