The Recognition Process - becoming a 'Recognised Centre'

To deliver iCQ Qualifications, or to deliver your own Qualifications 'Accredited by' iCQ, you must first become a 'Recognised Centre'. iCQ will appoint one of their EQA team to take you through the process - they'll help you create (if necessary), collate and upload all required documents (e.g. your Centre policies, your Staff CV's and qualifications, etc.), and will help you set up your online **iLearner** Centre ready to start registering Learners & Apprentices and to begin delivery. Once you become a recognised centre, the annual recognition fee will automatically be invoiced for on the anniversary of recognition, together with the annual confirmation of meeting the recognised centre requirements being required to be completed by your responsible officer

Qualification registration and access to **iLearner**

iLearner hosts the Journey for Learners and Apprentices and provides their Centres and staff with visibility and control. It builds ePortfolios and connects Learners & Apprentices with their Centres, their Assessors, their IQAs, EQAs, their Trainers and their End Point Assessors. Centres instantly get real-time learner tracking, insight into Quality monitoring and Assurance, embedded funding return (ILR) tools, Apprenticeship Gateway preparation (Pre-Gateway requirements) and much, much more. Once added to the system, a Learner or Apprentice can then be registered for **as many Qualifications and/or Apprenticeships as required**, forever, at **no extra cost**. The one-off, once-only, **iLearner** registration fee (per Learner/Apprentice) is....
